

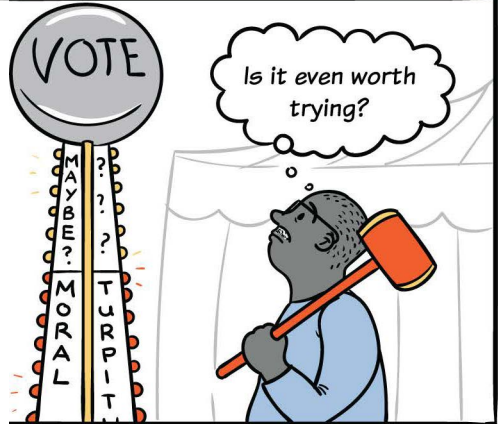


## IMPORTANT LEGISLATIVE UPDATE !

If you've been convicted of a felony, you can still register to vote in Alabama unless your crime involved "moral turpitude."

We used to have very little guidance about which crimes involve moral turpitude, and some people were unsure about whether they could exercise their right to vote.

So what counts as "moral turpitude"?



But in 2017, the state legislature passed a law that makes things clearer.

Now you don't have to worry about whether you can vote.

Only the crimes on this list involve moral turpitude!



Just check the list of crimes on the back of this flyer. If your crime isn't on there, you can vote!

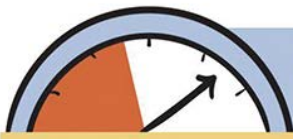

1. Aggravated child abuse
2. Aggravated theft by deception
3. Any crime as defined by the laws of the United States or by the laws of another state, territory, country, or other jurisdiction, which, if committed in this state, would constitute one of these offenses
4. Assault (1st or 2nd Degree except for 13A-6-20(a)(5) -DUI)
5. Attempt to commit an explosives or destructive device or bacteriological or biological weapons crime
6. Bigamy
7. Burglary (1st or 2nd Degree)
8. Conspiracy to commit an explosives or destructive device or bacteriological or biological weapons crime
9. Dissemination or public display of obscene matter containing visual depiction of persons under 17 years of age involved in obscene acts
10. Distribution, possession with intent to distribute, production of obscene material, or offer or agreement to distribute or produce
11. Electronic solicitation of a child
12. Endangering the water supply
13. Enticing a child to enter a vehicle or house for immoral purposes
14. Facilitating online solicitation of a child
15. Facilitating solicitation of unlawful sexual conduct with a child Soliciting a child by computer
16. Facilitating the travel of a child for an unlawful sex act
17. Forgery (1st or 2nd Degree)
18. Hindering prosecution of terrorism
19. Hindrance or obstruction during detection, disarming, or destruction of a destructive device or weapon
20. Human trafficking (1st or 2nd Degree)
21. Incest
22. Kidnapping (1st or 2nd Degree)
23. Manslaughter
24. Murder
25. Parents/guardians permitting child to engage in production of obscene matter
26. Possession and possession with intent to disseminate obscene matter containing visual depiction of persons under 17 years of age involved in obscene acts
27. Possession or distribution of a destructive device or weapon intended to cause injury or destruction
28. Possession or distribution of a hoax device represented as a destructive device or weapon
29. Possession, manufacture, transport, or distribution of a destructive device or bacteriological or biological weapon
30. Possession, manufacture, transport, or distribution of a detonator, explosive, poison, or hoax device
31. Production of obscene matter containing visual depiction of persons under 17 years of age involved in obscene acts
32. Prohibited acts in the offer, sale, or purchase of securities
33. Rape (1st or 2nd Degree)
34. Robbery (1st, 2nd, or 3rd Degree)
35. Selling, furnishing, giving away, delivering, or distribution of a destructive device, a bacteriological weapon, or biological weapon to a person who is less than 21 years of age
36. Sexual abuse (1st or 2nd Degree)
37. Sexual abuse of a child  $\leq$  12 years old
38. Sexual torture
39. Sodomy (1st or 2nd Degree)
40. Soliciting or providing support for an act of terrorism
41. Terrorism
42. Theft of lost property (1st or 2nd Degree)
43. Theft of property (1st or 2nd Degree)
44. Theft of trademarks or trade secrets
45. Torture or other willful maltreatment of a child under 18
46. Trafficking in cannabis, cocaine, or other illegal drugs or trafficking in amphetamine/methamphetamine
47. Treason
